Tarik Shaheen, MD - The answer would be yes, if the following criteria are met:

1. A complete physical exam has taken place (performed by an appropriate, authorized medical professional) and you have the patient records.
2. There is an established doctor-patient relationship
3. You are not prescribing for chronic pain
4. You are following the standard of care and doing the appropriate diagnosis and monitoring, using the appropriate telemedicine tools/peripherals

Talia McNamara, MD-Yes Yearly exams are appropriate and should meet the standard of care (for example, to monitor the effects of prescribed medications) and should be performed by an appropriate, authorized medical professional.

1. You must meet the Georgia standards of a Georgia licensee and you must also meet the standards of the state where the patient is located (refer to Georgia law and other state's laws)

Paul M. Bolger, MD MBA

If you have an established doctor-patient relationship, you are not subject to the three-day rule for meds. You must have performed an appropriate exam within the standard of care, using the proper telemedicine peripherals. Please refer to Rule 360-3-.07 (b)
