**CALL TO ORDER**

Dr. Retterbush called the meeting of the Georgia Composite Medical Board to order at 7:45 AM.

**EXECUTIVE DIRECTOR’S REPORT**

3. Asked the Executive Director to have the advisory committee members sign confidentiality agreements regarding applications and investigations.
4. Received a letter from the Board of Nursing regarding allegations of nurses operating lasers and medical spas, and asked the Executive Director to send complaints to the Board of Nursing for its investigations.
5. Reviewed Senate Bill 51 (2001), regarding the use use of automated external defibrillators, for possible rules. The Board referred the issue to the Rules Committee for review.
6. Received a letter from Joseph T. Van Horn, Esquire, requesting an advisory opinion on the application of regulation in the context of telemedicine, and referred his question to the Telemedicine Committee for its review at the November meeting.
7. Reviewed the Physician Profile rules regarding public comments included by physicians. The Board asked the staff revise profiles with inappropriate comments that did not relate to the information in the profile.
8. Received a letter from the National Transportation Safety Board. The Board accepted the letter as information.
9. Received a letter from David Will, Esquire, regarding a law change that would add an exemption to the pain clinic law for community service board. The Board accepted the letter as information.
10. Ms. Wray presented the report of hours and cases handled by the Office of the Attorney General on behalf of the Board. The Board accepted the report as information.
