I, PAUL SPENCER RUBLE, holder of License No. 064754 to practice medicine in the State of Georgia pursuant to O.C.G.A. Ch. 34, T. 43, as amended, hereby freely, knowingly and voluntarily surrender said license to the Georgia Composite Medical Board. I hereby acknowledge that this surrender shall be considered to be and have the same effect as a revocation of my license, and I knowingly forfeit and relinquish all right, title and privilege of practicing medicine in the State of Georgia, unless and until such time as my license may be reinstated, in the sole discretion of the Board.

I acknowledge that I have read and understand the contents of this Voluntary Surrender. I understand that I have a right to a hearing in this matter, and I hereby freely, knowingly and voluntarily waive such right. I also understand that should the Board entertain any request for reinstatement, the Board shall have access to any investigative or medical information regarding me. I further understand that upon applying for reinstatement, it shall be incumbent upon me to demonstrate to the satisfaction of the Board that I am able to practice medicine with reasonable skill and safety to patients, and that the Board may investigate my conduct since the time of the surrender of my license. I understand and agree that any reinstatement of my license to practice medicine is a matter in the sole discretion of the Board and that the Board may deny any such reinstatement without identifying a reason for said denial.

This surrender shall become effective upon acceptance and docketing by the Board. I understand that this document will be considered to be a public record evidencing disciplinary

action, and that this action shall be considered to be and may be disseminated as a final order of the Board.

**ORDER LIFTING SUMMARY SUSPENSION**

1.

WHEREAS, Respondent was licensed by the Georgia Composite Medical Board ("Board") to practice as a physician in the State of Georgia on or about May 10, 2007 and his license expires September 30, 2018.

WHEREAS, on or about June 7, 2016, the Board summarily suspended Respondent's license based on Order of Suspension entered by the Colorado Medical Board on or about May 25, 2016, relating to boundary violations involving an alleged Georgia patient.

3.

WHEREAS, on or about March 27, 2017, the Board received reliable information that the Colorado Medical Board, following a hearing, had entered an Order to Terminate the Suspension of Respondent's license. Whereas, the Board received reliable information that following the hearing in Colorado, the administrative law judge found there was no practice below the minimum standard of practice and recommended no disciplinary action.


NOW THEREFORE, the Board lifts the suspension of Respondent's license to practice as a physician in the State of Georgia, and he is restored to active status and good standing.


