CALL TO ORDER

Dr. DeLoach called the meeting of the Georgia Composite Medical Board to order at 7:30 a.m.

RULES HEARING

Dr. Weil convened the Public Hearing concerning the following proposed Rules amendments:

Rule Chapter 360-15-.01, “Requirements for Physicians.”

Dr. Retterbush asked if anyone was present to address the Board on the posted Rules amendments.

Bethany Sherrer, MAG made comments opposing mandated CME.

After hearing comment Dr. Retterbush made a motion to amend Rule Chapter 360-15-.01, “Requirements for Physicians” and the Board find the formulation and adoption of these rules do not impose excessive regulatory cost on any licensee and any cost to comply with the rule cannot be reduced

by a less expensive alternative that fully accomplishes the objectives of the applicable laws; that the Board finds that it is not legal or feasible to meet the objectives of the applicable laws to adopt or implement differing actions for businesses as listed in O.C.G.A. 50-13-4(A) (3)(A),(B),(C), and (D). Dr. Marshall seconded the motion, and it carried unanimously.

Rule 360-35-.01, “Definitions.”
