EXECUTIVE DIRECTOR REPORT

1. Letter from John Harvey MD regarding the Medical Reserve Corp Who may oversee resident physicians while they are volunteering outside the walls of their residency facility? The Board discussed and decided to refer to MAG to check with the residency programs.
2. Darren Rothschild, MD – Forgot to renew and does not want to go through the reinstatement process. The Board responded that he must complete the reinstatement process.
3. Dana C. Thielmann – are psychiatrist required under OCGA 30-5-4 to report instances of suspected abuse inflicted upon one of their patient. The Board responded that the answer is yes, must be reported.
4. Matthew Klemic – opening a portable IV Hydration station to set up a tent after endurance races. Must have each patient evaluated by a physician, nurse practitioner, or physician assistant for diagnosis and treatment.
5. Ms. Hughes notified the Board that 96% of all physicians with a DEA number has registered with the PDMP. The Board discussed the penalties and possible discipline for failure to register or failure to check the PDMP.
