VOLUNTARY SURRENDER

I, ROGER BLAIR, P.A., holder of License No. 6111 in the State of Georgia, pursuant to O.C.G.A. Ch.34, T. 43, as amended, hereby freely, knowingly and voluntarily surrender said license to the Georgia Composite Medical Board (hereinafter "Board"). I hereby acknowledge that this surrender shall have the same effect as revocation of my license, and I knowingly forfeit and relinquish all right, title and privilege of practicing medicine in the State of Georgia, unless and until such time as my license may be reinstated, in the sole discretion of the Board.

I understand that I have a right to a hearing in this matter, and I hereby freely, knowingly and voluntarily waive such right to a hearing. I understand that I cannot apply for reinstatement for two years from the date of the surrender of my license under the rules of the Board. I also understand that should any request for reinstatement be entertained by the Board, the Board shall have access to any investigative file in this matter. I further understand that upon applying for reinstatement, it shall be incumbent upon me to demonstrate to the satisfaction of the Board that I am able to practice medicine with reasonable skill and safety to patients, and that if the Board is not satisfied, the Board shall not reinstate my license.

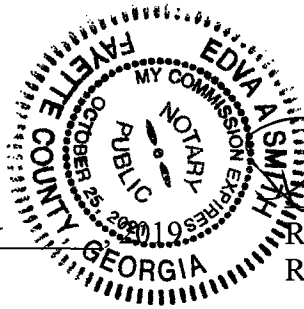

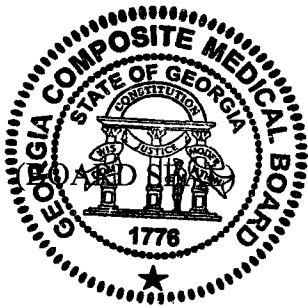

ORDER LIFTING DEA RESTRICTION

**WHEREAS**, on or about June 7, 2018, Michael Nelson Brady M.D. (“Respondent”) entered into a Public Consent Order (“Order”) with the Georgia Composite Medical Board (“Board”), Docket No. 20180050, which subjected Respondent’s license to various terms and conditions that went into effect upon the lifting of the imposed suspension on April 13, 2019.

**WHEREAS**, Paragraph 2(b) of the Order provides that Respondent relinquished his right to prescribe, administer, dispense, order or possess (except as prescribed, administered, or dispensed to Respondent by another person authorized by law to do so) controlled substances as defined by the Federal or Georgia Controlled Substances Act, until further order of the Board.

**WHEREAS**, on or about July 12, 2019, the Board received a request from Respondent to terminate Paragraph 2(b) of the Order, having taking the course entitled, “Appropriate Prescribing of Controlled Substances” sponsored by the Mercer University Southern School of Pharmacy in Atlanta and otherwise remaining in compliance with the

terms of the Order, the Board hereby ORDERS that the DEA restriction placed on Respondent's license to practice as a physician in the State of Georgia be LIFTED.

WHEREAS, Respondent's license shall remain subject to the remainder of the probationary terms and conditions imposed upon Respondent's license in the June 2018 Order.

IT IS SO ORDERED this 25th day of November, 2019.

ORDER OF SUMMARY SUSPENSION

1.

WHEREAS, KRISTI MICHELLE LEWIS, RCP, ("Respondent") is licensed by the Georgia Composite Medical Board ("Board") to practice respiratory care in the State of Georgia. Respondent was issued a license on August 5, 1999, and Respondent's license will expire on January 31, 2020.

2.

WHEREAS, on September 10, 2019, the Board issued a Confidential Order for Mental/Physical Examination ("Order") for Respondent. The Order was based on the following information:

- (a) On or about April 17, 2019, the Director of Respiratory Care (DRC), at Respondent's place of employment, observed that Respondent was acting erratically. Respondent was unable to complete her sentences; Respondent was constantly moving; and Respondent was unable to complete medical charts.
- (b) On or about April 25, 2019, at the request of Respondent's employer, Respondent submitted to a drug screen. The results of the drug screen were positive for Amphetamine and Methamphetamine.

- (c) On June 6, 2019, Respondent sent a statement to the Board indicating that she did not use illegal drugs; and that approximately one month before the drug screen, she had started taking Sudafed and drinking energy drinks.

3.

WHEREAS, Respondent was personally served with a copy of the Order on September 12, 2019.

4.

WHEREAS, as of the docket date of this Order, Respondent has not provided the Board with the results of a mental/physical evaluation.

5.

NOW THEREFORE, the Board finds that Respondent's continued practice of respiratory care poses a threat to the public health, safety, and welfare and imperatively requires emergency action and hereby ORDERS that Respondent's license to practice respiratory care in the State of Georgia be and is hereby SUMMARILY SUSPENDED pursuant to O.C.G.A. § 50-13-18(c)(1), pending further proceedings on behalf of the Board, which shall be promptly instituted.

If the Respondent wishes to have an expedited hearing, Respondent shall execute and file with the Office of State Administrative Hearings the original and one copy of the attached REQUEST FOR EXPEDITED HEARING no later than fourteen (14) days from the day of service or receipt of this Order. Respondent also shall serve a copy of such REQUEST upon counsel for the Board as identified in the REQUEST.


