# Acupuncture Application Checklist

# **Eligibility Requirements**

- \_\_\_\_Must be at least 21 years old and of good moral character.
- \_\_\_\_Successfully complete an accredited acupuncture program.
- \_\_\_\_Pass the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) examination.

\_\_\_\_Obtain Clean Needle Technique (CNT) certification from the Council of Colleges of Acupuncture and Oriental Medicine (CCAOM).

# Application, Fees, & Required Documents

\_\_\_\_Complete Application – Available on <u>https://gcmb.mylicense.com/egov/Login.aspx</u>.

- \_\_\_\_Application Fee \$300 (non-refundable, payable via cashier's check or money order).
- \_\_\_\_Notarized Affidavit of Applicant (Form A) Must include a passport-sized photo.
- \_\_\_\_Affidavit of Citizenship Submit proof of U.S. citizenship or legal residency.
- \_\_\_\_Certification of Education (Form C) Must be sent directly from the acupuncture school to the Board.
- \_\_\_\_Exposure Control & Infectious Disease Prevention Training (Form D) Verification of training completion.
- \_\_\_\_Certification Verification Request (Form E) Must be sent directly from the issuing organization (NCCAOM).
- \_\_\_\_State Verification (Form F) If licensed in another state, provide official verification.

\_\_\_\_CV/Resume - Work History – List acupuncture-related employment and address any gaps. Applicant must provide three (3) references on official letterhead:

- One reference from a licensed U.S. physician (MD or DO) practicing in the same jurisdiction and familiar with the applicant's practice.
- Two references from practicing acupuncturists familiar with the applicant's practice.

\_\_\_\_Plan of Supervision – Before starting supervised practice, the supervisor must submit a letter of intent and supervision plan for Board approval, in consultation with the Advisory Committee.

Applicants with less than one year of postgraduate clinical experience must complete one year of supervised practice under a licensed acupuncturist with four years of active practice. The supervisor may be licensed in Georgia or another jurisdiction with substantially equivalent requirements, with experience accumulated across qualifying jurisdictions.

### Additional Requirements (if applicable)

- \_\_\_\_Non-U.S. Citizens Provide immigration documents verifying legal residency status.
- \_\_\_\_Name Change Documentation If applicable, submit a marriage certificate or court order.

### License Renewal, Continuing Education, Rules & Laws

- \_\_\_\_Renewal Fee \$105 every renewal cycle (biennially).
- \_\_\_\_Continuing Education Requirements 40 hours of Board-approved CE, including 1 hour concerning infectious disease.
- \_\_\_\_Late Renewal Fee \$205 if not renewed on time.
- \_\_\_\_Reinstatement Fee \$400 for lapsed/revoked licenses, \$200 for inactive licenses.
