 - **William Lagaly, DO**: Supervision of hyperbaric oxygen therapy by podiatrists. The Board tabled this discussion.

 - **Adam Tribbett**: Questions about PA Additional Duties and APRN Form Cs. The Board recommends if an APRN has been previously approved by the GCMB for a Form-C under a different delegating physician, a copy of the Board's approval letter may be submitted in lieu of procedure logs. Pas already have this policy in place.

 - **Kimberly Works, MD**: Question about Pediatrics and Low THC Oil

Dr. Marshall motioned, seconded by Dr. Norman, to go into closed session to discuss confidential matters. The motion carried unanimously.

OPEN SESSION

Dr. Bostock declared open session.

RULES COMMITTEE REPORT

Dr. Gross presented the Rules Committee Report as a motion. Dr. Bhat seconded. The motion carried unanimously. The Board took the following actions:

Dr. Marshall motioned, seconded by Dr. Norman, to post Rule 360-32-.05 “Additional Requirements Regarding Physician Delegation to an APRN” to the website for public comment.

The Committee discussed the issue of physicians not signing/certifying death certificates and decided to table the matter for now. Dr. Marshall motioned, seconded by Dr. Antalis, to invite representatives from the Dept. of Public Health to discuss the issue further. In addition, the Board’s Executive Director and Deputy Director are working with a Legislative work group regarding this matter.

The Committee also discussed a proposed statute change for “midlevel dispensing of dangerous drugs.” This proposed statute change was presented to the Committee by Capitol Strategy Group, Inc. Mr. Devin Krecl, Dr. Brad Keel, and Ms. Ashley Berry joined the call to contribute.

Mr. Dorsey shared updates on the topic of physicians signing death certificates and the legislative workgroup looking into the issue.

The Committee considered a petition from Walgreens to waive Rule 360-34-.01(8)(a). Dr. Marshall motioned, seconded by Dr. Norman, to deny the petition because the language in the Rule is consistent with the statute and the Board does not have the authority to waive the law.

The Committee discussed correspondence from Raquel Boton from Thompson Coburn, LLP, concerning a clarification request on the use of term “medication” in Rule 360-3-.02(5). Dr. Marshall motioned, seconded by Dr. Norman, to draft a proposed amendment to this Rule and bring it back to the Committee.

NURSE PROTOCOL ADVISORY COMMITTEE REPORT

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Gangasani seconded. The motion carried unanimously. The Board took the following actions:

The Committee recommended the following:

1. C. L with H.L asked about Nurse Practitioners opening IV hydration practice.
Committee's response: "APRNs need an agreement in order to operate [an IV Hydration business] and should have a delegating [physician] with specialty such as Family, Primary, Internal, and or Emergency." In addition, per O.C.G.A §16-13-71(b)(474), "injections, all substances for human use" are classified as dangerous drugs in Georgia with few exceptions. In general, this would mean that a prescription would be required.
2. J.W inquired about collaborating with a gynecologist on medical weight loss.
Committee's response: The APRN would need to do a separate protocol agreement and submit it to the board for consideration.
3. M.C asked about Botox Injections.
Committee's response: The APRN would need a collaborative practice agreement to do Botox also, the supervising physician cannot be employed by the APRN. The committee cannot dispense legal advice, please consult with your attorney to answer parts two and three of the question.
4. A.T at Emory had questions about Form C's
Committee's response: The discussion will be put before the full board.
