**NURSE PROTOCOL ADVISORY COMMITTEE**

Dr. DeLoach presented the Nurse Protocol Report:

The Board took the following actions:

1. Seeking clarification on how physician supervision of mid-levels and extenders (e.g., nurse practitioners and physician assistants) worked. **Answer: A physician can supervise 4 NP's unless exempt, can have 8 NP's but only 4 working at a time. PA's went from two to four in 2020. Advised to review Georgia code 43-25-1.**
2. Milene Vega, Latham & Watkins, LLP – Clarification regarding CRNA's and PA's. Answer: (1) CRNA's do not have the ability to prescribe in Georgia. **Please defer to law. Language refers to nurses. (2) Yes, PA's can order controlled substances in hospital setting. (3) No mandate for PA to register with DEA.**
