NURSE PROTOCOL ADVISORY COMMITTEE

Dr. Norman presented the Nurse Protocol Report:

The Board took the following actions:

The Committee recommended the following:

1. Are Hoods required for IV mixing? Do infusions need to be premixed or can they be mixed by a nurse Practitioner or RN? Who can administer IV infusions RN, LPN, CNA, EMT, PA, MD, LVN?
Answer: To consider what is compounded contact Nursing and Pharmacy board.
2. If a PNP was working at a college health clinic (an acute ambulatory clinic), the provider could only provide care to patients 21 or younger? Or can the PNP provide care to 22-26, if it was in their scope of practice and consistent with similar diagnosis seen in 21 or younger patients?
Answer: The rules and law state the cut off age is 21.
3. Can a specialist physician such as OB-GYN or oncologist, be a supervising for an IV hydration/medical spa in the state of Georgia?

Answer: The supervising physician has to be with similar specialty.

4. Several psychiatric nurse practitioners are needing supervision to treat growing demands for psychiatric care in Georgia. Based on the many years of experience and supervision, and the growth of synchronous technology specialized psychiatric supervision can reach urban and rural communities previously underserved in psychiatry.

Answer: The physician cannot supervise the NP's from another state with a telemedicine license.
