#### **Questions:**

I am an anesthesiologist in Georgia. I have 2 CRNAs that are starting a "med spa" and they want me to be the medical director for it. I have tried reading through the GCMB rules and regulations, but I still have a few questions. I want to make sure everything is completely legal and done correctly.

1. Are CRNAs considered to be APRNs, according to GCMB? **Yes**
2. Are APRNs allowed to own a "med spa" in Georgia? Per one of your rules, it states that they must be supervised by a physician and the physician cannot be "hired" by the APRNs? **Questioner may wish to consult a lawyer.**
3. If the physician cannot be "hired" by the APRNs, does that mean the physician must be an owner of the "med spa", or can the physician work with them as an independent contractor? **Questioner may wish to consult a lawyer.**
4. According to GCMB, it states a nurse protocol agreement can be signed to allow them to perform injections without me physically being present in the office. Is that correct? **Yes.**
