**PHYSICIAN LICENSURE COMMITTEE REPORT**

Dr. Gross presented the Licensure Committee Report as a motion. Dr. Gangasani seconded. The motion carried unanimously. The Board took the following actions:

Questions/Requests/Correspondence

1. Sternschuss, Adam Can an expert who is licensed to practice medicine in a different state, who is not licensed to practice medicine in your state, cross state lines to perform an IME on behalf of a lawsuit? If the physician requires temporary licensing, what is the process to obtain this? What is the cost? How long in advance are they required to obtain these privileges? Is there a difference in licensing procedures if the IME were to be performed virtually through a HIPPA compliant secure video platform?  
RESPONSE: Yes, an expert who is licensed to practice medicine in a different state, who is not licensed to practice medicine Georgia, can cross state lines to perform an IME on behalf of a lawsuit. GA State law allows that physicians from other states and foreign countries may be permitted to enter the state for consultation with any licensed physician of this state.
2. Young, Andrew - With the Medical Board ending their tele health flexibility without an in-person visit be grandfathered and remain valid or not? Second, can a Physician-Patient relationship between a Georgia-Licensed Physician and a Georgia Patient be established by an in-person visit that takes place outside of Georgia? If for example, a patient moves from Florida to Georgia and their physician is license in both states and had already performed an in-person evaluation in Florida, would that satisfy the requirement and establish the relationship for Georgia as well? And finally, some of our patients are receiving Office-Based Addiction Treatment for Opioid Use Disorder. While we would only be prescribing at this location (not dispensing, storing, or administering), would it be necessary to get a special registration for OBAT at that Physical location?  
RESPONSE: After May 2024, physicians will be required to return to the first in-person contact to practice Telemedicine, there is no grandfathering provision. There are no restrictions on where an in-person examination takes place. The Georgia Composite Medical Board is not involved with registration for office-based addition treatment.
3. Brake, Gaines - Looking for guidance pertaining to practice by physicians located outside the state of Georgia (and not licensed in Georgia) who treat Georgia residents out of state. The Scenario is - Georgia resident travels out of state and is administered tests by physician license in the other state. Georgia resident returns home before test results are obtained. Results come back and out of state physician would like to report results to Georgia resident.  
RESPONSE: Any actions beyond communication of test results to the patient may constitute practice of medicine and require a Georgia medical license pursuant to the Georgia Medical Practice Act.

**NURSE PROTOCOL ADVISORY COMMITTEE REPORT**

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Norman seconded. The motion carried unanimously. The Board took the following actions:

Questions:

GACSB-GCMB Letter:

Question: GACSB requests that GCMB take into consideration the experience of APRNs in a field when determining if the APRN and delegating physician have comparable specialties.

Response: The board does take experience and education into consideration.

Anthony Herrington:

Question: Requestor's hospital will not allow APRNs to order schedule II-controlled substances for patients. Requestor states that the hospital interprets the terms "ordering" and "prescribing" as synonymous within Georgia's existing legislation. The hospital requires the attending physician to enter orders for schedule II-controlled substances.

Response: No, he cannot.

Neena Bhatia:

Question: Is a FNP authorized to conduct immigration physical examinations with a collaborating Civil Surgeon MD?

Response: Please contact the federal government.

Shannon Waller:

Question: APRN took another job but is returning part-time, does the protocol need to be terminated and resubmitted?

Response: It is up to the employer/organization to determine when they are going to terminate the agreement. Until the agreement is terminated, it remains in effect.

Nadia M:

Question: Can an APRN practice independently in Georgia as a Certified Medical Examiner for DOT?

Response: Please consult with your personal lawyer and review the Federal guidelines surrounding your request. The Board does not regulate or determine such cases.

Care Connect Inc:

Question: Organization is an FQHC, and physicians can supervise up to 8 APRNs. Does this include APRNs that are not affiliated with the organization? Ex. Physician supervises 6 APRNs for the FQHC, is the physician permitted to supervise 2 additional APRNs outside of the FQHC for a max of 8 or if a physician already has 4 APRNs outside the FQHC, can they still supervise an addition 4 who are affiliated with the FQHC?

Response: Question tabled until the next meeting.
