CHAIR'S REPORT

Dr. Cheek reminded Board members about recusal packets and took a headcount for the May 07, 2026, meeting, which will be held in-person at the Board office.

EXECUTIVE DIRECTOR'S REPORT

Mr. Jones shared updates that were for information purposes only.

CORRESPONDENCE AND DISCUSSION ITEMS

1. Correspondence from Baylee Culverhouse, Husch Blackwell LLP:

- Are registered nurses permitted to administer Propofol, Etomidate, and neuromuscular blocking agents (only Succinylcholine, Rocuronium, and Vecuronium) to non-intubated patients in a hospital setting for the purpose of rapid sequence intubation when the clinical presentation of impending respiratory failure is imminent in the presence of, and under the direction of, a physician assistant?

Response: Refer to the Board of Nursing with a recommendation that, should the Board choose to update/expand its policy, physician assistants be required to have and maintain advanced training in the procedures and emergency management.

2. Correspondence from Kayla Howard, BHG Tifton Treatment Center:

- Are Nurse Practitioners (“NP”) permitted to prescribe or titrate methadone dosages for patients receiving treatment? If NPs are not authorized to prescribe or adjust methadone doses, are they allowed to evaluate and assess patients who are currently receiving methadone therapy?

Response: Nurse Practitioners are not permitted to prescribe or titrate methadone. The prescriber should be the person evaluating/assessing patients receiving methadone therapy.

- In an addiction clinic setting, if a patient presents with no change in their current methadone dose (for example, 80 mg daily), may an NP document in the treatment plan that the patient should continue the current dose of 80 mg PO daily?

Response: No, they should not be managing or recommending a treatment plan.

- When drafting a collaboration protocol agreement, is it necessary to specify the individual medications that will be prescribed within the addiction treatment center?

Response: It is not necessary to specify individual medications, but a collaboration protocol agreement may not permit nurse practitioners to prescribe methadone.

3. Correspondence from Brigit Dunne, McDermott Law:

- Pursuant to O.C.G.A. § 43-34-31(b), would a pathologist be required to have a GA license in the following scenario? The out-of-state pathologist would be consulting on clinical trial central lab services. The sample review by the out-of-state pathologist would not be a typical consultation but, rather, a clinical trial/protocol-driven Requester + Staff “double-checking” of the clinical trial patient's original diagnosis; any results, including any discrepancies, would separately be addressed by the in-state physician in consultation with an in-state pathologist as needed (consultation outside of the clinical trial and as part of the patient’s medical care).

- Response: No, an out-of-state pathologist in this scenario would not be required to obtain a Georgia physician license to consult as part of the clinical trial.
4. Correspondence from Sarah Crotts, Parker Poe:
- May a provider (who is a sole practitioner) transfer custody and control of the provider's medical records to a hospital with which the provider has entered into a management services agreement? Under the management services agreement, the hospital will be responsible for billing and collection services for the provider, which requires hospital personnel to have access to the medical records. Unfortunately, the provider doesn't have a very useful system for maintaining medical records currently, so the hospital has asked whether it can take custody and control of the records and transfer them into the hospital's EMR for better record-keeping and easier billing. The physician will continue to own their practice (there is no sale of the practice or its assets, and no retirement involved). If we include language in a medical records custody transfer agreement that makes clear that the physician will have continued access to the records even if/when the management arrangement ends, would that be sufficient to permit the provider to transfer custody and control of the medical records to the hospital? Would this be permitted under O.C.G.A. § 31-33-2?
Response: There is no prohibition, but the physician must retain access to the records at all times.
5. Correspondence from Jeanette Leader, MD:
- Is it permitted to employ a 17-year-old assistant in clinical care in a medical office? Our medical office is considering hiring a 17-year-old pre-medical college student to assist physicians in our practice. In this role the student would:
 - receive the same HIPPA and patient privacy training as all adult staff members
 - assist with patient check-in and general office workflow
 - assist physicians as a chaperone during physical examinations and assist during in-office proceduresWe would ensure that the student is appropriately trained, supervised and compliant with all privacy and confidentiality standards. After reviewing the information available on the Georgia Composite Medical Board website, we were unable to identify any specific age requirements or restrictions related to this type of role. We would appreciate your guidance on whether employing a 17-year-old in this capacity is permissible under Georgia law and Board regulations.
Response: No, one must be at least 18 years old to be involved in patient care or procedures.

- HB 162 - Georgia Composite Medical Board; implement an automated credentialing system for healthcare providers in this state
- HB 382 - Controlled substances; Schedule I; psilocybin; revise a provision
- HB 571 - Professions and businesses; licensing of radiologist assistants
- HB 717 - Medical Practice Act; regulation of the administration of psychedelic-assisted treatment and therapy

- HB 1138 - Increasing Access to Contraceptives Act
- HB 1247 - Georgia Bureaucratic Deference Elimination Act
- HB 1275 - Medical practice; ensure that stem cell therapies are used to advance medical treatments and improve patient outcomes in an ethical manner that does not involve stem cells derived from aborted fetuses
- SB 162 - Georgia Composite Medical Board; implement an automated credentialing system for healthcare providers in this state
- SB 195 - Pharmacies; pharmacists are authorized to dispense preexposure prophylaxis and postexposure prophylaxis under certain conditions
- SB 207 - Professions and Businesses; a preclearance process in the licensing of individuals with criminal records who make application to or are investigated by certain licensing boards and commissions
- SB 220 - Putting Georgia's Patients First Act
- SB 395 - Department of Public Health; eligible for the Low THC Oil Patient Registry; require a physician to submit certain information to the Georgia Composite Medical Board
- SB 427 - Physicians; limited provisional licenses and a pathway to licensure for certain internationally trained physicians

NURSE PROTOCOL ADVISORY COMMITTEE REPORT

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Marshall seconded. The motion carried unanimously. The Board took the following actions:

Questions/Correspondence/Discussion:

1. Correspondence from Darly Micourt

- Given my history of independently performing IUD insertions and removals for several years in public health settings, I am requesting guidance on the following:
 1. What is the pathway to regain or reapprove my status to perform IUD insertions and removals?
 2. Is there an alternative to supervised logging for experienced providers with documented procedural history?

Response: Based on the information provided, your delegating physician would still be required to sign the form and write a statement that he/she attests that you are competent to perform the procedure(s) being requested.

2. Correspondence from Magnolia Manager

- Currently, our NP practices under the supervision of a pediatrician. However, as discussed, the pediatrician may leave the practice soon. If that happens, we have arranged for the NP to transition under the supervision of Dr. Ravi Shah, an internist. He was approved as her supervising physician.
- If the pediatrician leaves, can the NP continue seeing pediatric patients under Dr. Ravi Shah's credentialing and billing, or would the NP need to move to direct credentialing and billing?

Response: This Board does not provide advice or guidance regarding credentials or billing. If the physician is working in a comparable specialty and is seeing the pediatric patients, then he can submit a protocol with the pediatric nurse for review. If the physician is not treating pediatric patients on a regular basis, then he should not be
