NURSE PROTOCOL ADVISORY COMMITTEE REPORT

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Bhat seconded. The motion carried unanimously. The Board took the following actions:

Questions/Correspondence:

Stephanie Awanyai:

Question 1: How does the Board define “principal place of practice”?

Response: The plain language meaning of the phrase, which is the primary practice location of the physician, i.e. where the physician practices the majority of their time.

Question 2: Can the Board interpret the last sentence of O.C.G.A. § 43-34-31(a) “Any such out-of-state or foreign practitioner shall not have ultimate authority over the care or primary diagnosis of a patient who is located in this state.”

Response: A legislative interpretation/clarification would be required to interpret this in any way other than plain language. Please note that a physician is responsible for all care provided by themselves or their delegates.

Question 3: Does Georgia law require the initial patient visit to be with a physician as opposed to a nurse practitioner?

Response: A nurse practitioner could potentially conduct an initial patient visit so long as (1) there is not a prescription for a controlled substance, (2) there is no other prevailing state or federal statute or regulation requiring the physician to conduct the initial examination, and (3) the physician and nurse practitioner are abiding by all the Georgia laws and rules including, but not limited to, Rules 360-3.06 and 360-3-.07.

Amy Kattrein:

Question 1: For the annual review meeting, if the nurse practitioner is not located in Georgia, can the meeting take place outside of Georgia?

APPEARANCES BEFORE THE BOARD

Dr. Jeffrey Turell, MD appeared before the board with his attorney, Melvin Goldstein, Esq., to appeal the Board's decision to deny licensure based on failure to complete two residency training programs.

Dr. Gross made a motion, seconded by Dr. Marshall, to rescind the denial and grant licensure, to inform Dr. Turell that his practice plan to be a delegating physician for APRNs in Georgia is not permitted by law as he does not meet the location requirements, and to send a letter to the telehealth company that employs Dr. Turell with information about GA laws and rules. The motion carried unanimously.

Dr. Douglas Moss, MD appeared before the board to appeal the Board's decision to deny licensure based on disciplinary action taken against him by another state and a criminal conviction.

Dr. Gross made a motion, seconded by Dr. Marshall, to uphold original decision of denial or allow to withdraw. Dr. Retterbush recused himself from this matter.

LEGISLATIVE UPDATE

The Board held a discussion about last year's Senate Bill 529 regarding International Medical Graduates which will be reintroduced in some fashion this year. The Board would optimally like this legislation to be delayed until the 2026 legislative session to allow the Federation of State Medical Boards to complete its research and pass best practice guidelines to assist states in formulating better statutes. In lieu of a delay, the Board would like Senator Jackson and her team to consider amending the current Institutional License statute (O.C.G.A. § 43-34-33) rather than creating new licenses.
