AGENCY HEARING

The Board conducted an Agency Hearing on the matter of Victor Tseng, M.D., Respondent, to hear new evidence regarding Respondent's felony conviction which was not available in November 2024 during the Agency Review Hearing. The hearing was held at the request of the Board. Kimberly Emm presided over the hearing. Respondent was present and represented by Susan Levy and Dillon McConnell of Levy Pruett Carter.

Michelle Sawyer, Senior Assistant Attorney General, was present and represented the Board. This proceeding was audio recorded.

Ms. Sawyer delivered her oral arguments. Respondent testified and his attorney delivered oral arguments. After questions from the Board, the review ended.

All parties left the hearing while the Board deliberated in Executive Session.

Dr. Norman read the Findings of Fact and the Board's Conclusion into the record:
Conclusion:

The Board has considered the additional evidence of the criminal conviction of Victor Tseng for 4 counts of felony sexual exploitation of children. The Board finds this information relevant to the matter of the revocation of Victor Tseng medical license.

The Board considered these findings of fact and feels the superior court should also understand its rationale for making this important decision to protect the public. The Board's consideration of this matter was neither arbitrary nor capricious.

Findings of Fact:

- Diagnosis was not made by a physician.
- The diagnosis of Pedophilia OCD or Anti-Pedophilia is not in the Diagnostic Statistical Manual 5th Edition – text revision (“DSM-5”) therefore it is not widely accepted nor is it established as generally accepted by peer review. The Board has doubts as to the validity of this diagnosis.
- This is an act of moral turpitude, there were 4 counts of sexual exploitation of children.
- Respondent’s own counsel stated today, during the new evidence hearing, that this diagnosis is incurable but manageable. The Board is concerned that the public is at risk and will remain at risk of this incurable pseudo-disease.
- In the original hearing, (See page 157 and 167-168 of the OSAH Transcript), there was evidence that Respondent’s intrusive thoughts impaired his pediatric training in a clinical setting.
- This was not only viewing child pornography, but it was downloading it in a shareable form, from a dark web platform.
- The Board feels that being on the Sex Offender Registry is not sufficient to put the public on notice as the public expects the Board to protect them and a Sex Offender Registry search is not typical when the public is searching for a physician.

A poll was taken for each Board member who participated in the deliberations and voted. 13 Board members were present at the time of the vote. 13 members agreed with the decision; 0 members disagreed. The vote was unanimous.

Dr. Gross made a motion that the revocation stands, Dr. Marshall seconded the motion, 13 Board members were present at the time of the vote. 13 members voted in favor of the motion; 0 members dissented. The motion carried.

Mr. McConnell objected to the Board’s findings of fact stating that the statute only allows for modification on grounds of new evidence. The Board feels that its decision is based on the grounds of the new evidence and information provided by counsel. Mr. McConnell renewed his objection, which is noted for the record.
