NURSE PROTOCOL ADVISORY COMMITTEE REPORT

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Marshall seconded. The motion carried unanimously. The Board took the following actions:

Questions/Correspondence:

Correspondence from Elizabeth Mitchell: acute care NP inquiry re: scope of practice, Form C, Form C documentation, and proctoring.

(1) Are the following procedures in my scope of certification specialty? central line placement, arterial line placement, thoracentesis, paracentesis, small bore chest tube placement, PA catheter placement.

Response: Procedures would be within the scope of practice for an Acute Care NP who has completed an accredited acute care advanced degree program. The question then becomes was the educational training adequate on each procedure.

(2) I learned how to do these procedures in my graduate program, but I did not master them until I was in my job. Do I still need to submit training documentation?

Response: As the Committee does not have any information on education or training, it cannot verify the above procedures were covered adequately. At the discretion of the facility to require submittal of a Form C to the Board. Procedure logs from education can be submitted.

(3) My hospital system thinks that GCMB will label an APP as a proctor for procedures. Is this true?

Response: No, the Board does not certify, label, or designate APRNs as proctors.

Correspondence from Nnenna Onyeukwu

(1) Are APRNs able to order medical imaging tests (x-rays), labs or conduct pap smears without delegation strictly for veterans and service members?

(2) If the APRN works for a federal agency like the VA, are they mandated to obtain licensure in every state they perform a Compensation and Pension (C&P) exam or Physical Assessment?

Clarification was received that the inquirer is not employed with the VA, but a subcontractor.

Response: Only employees of the VA are covered by the VA exemption of licensure in each state of practice. The inquirer and nurses that work for her company will need GA licensure and proper protocol agreements to treat patients in Georgia.
