**CORRESPONDENCE AND DISCUSSION ITEMS**

1. Correspondence from Cara Weiner, SMR&W P.C.- Can GA licensed physicians privileged at a hospital perform telehealth admissions if the patient's history/physical exam was performed by midlevel?  
Response: Refer to hospital systems' admission procedures and/or confer with the hospital's credentialing committee.
2. Correspondence from Danielle Henderson- Can testosterone be procured for office use under APRN DEA registration or are APRNs limited to prescribing for patient-specific use?  
Response: Tabled for AG's office research
3. Correspondence from Gerald Gaul, MD – requested review of proposed non-medical "Tactical Refraction" exam.  
Response: Please refer to the laws and rules of Georgia; Request for appearance has been denied.
4. Correspondence from Lindsay Dowis, MD – Can APRNs call in or e-prescribe medications under a supervising physician's name under a O.C.G.A. § 43-34-23 protocol?  
Response: Refer to APRN Committee
5. Correspondence from Tisha Titus, MD, MPH – Does GA law require a formal supervisory agreement to authorize delegations of clinical trial responsibilities?  
Response: Please refer to your Institutional Review Board and the FDA for proper authority.
6. Correspondence from Jackie Gomez, Life RX Telemed -Does GA law permit the use of asynchronous telehealth methods to establish a valid patient-provider relationship for prescribing non-controlled medications such as PDE5 inhibitors. If not, is synchronous audio-video consultation required?  
Response: No, asynchronous telehealth does not meet requirements. Synchronous telehealth may be permitted. Please see Board Rule 360-3-.07 Practice through Electronic or Other Such Means.
7. Correspondence from Laura Dona, AGG- For the purpose of retaining medical records, under Board Rule 360-3-.02, how is an "active" patient defined?

8. Correspondence from Sydney Bierhoff, DLA Piper LLP- Can a GA urology practice retain its single-specialty status if interventional radiologists perform related procedures for urology patients?
