# Board partners with CE Broker for continuing education tracking and compliance

Licensees can sign up for a free account with CE Broker, or they can upgrade to a premium account with more features.

#### Dr. George Harrison appointed as newest Board member

# Georgia Medicaid extends deadline for provider revalidation

Georgia Medicaid and PeachCare for Kids providers now have until Oct. 31, 2023, to revalidate enrollment in order to avoid any disruption in the provision of care to their patients. Providers should log into the GAMMIS system to complete the brief revalidation process, and a training video is linked below to assist providers with completing the process.
