**PHYSICIAN LICENSURE COMMITTEE REPORT**

Dr. Gross presented the Licensure Committee Report as a motion. Dr. Norman seconded. The motion carried unanimously. The Board took the following actions:

**Questions/Requests/Correspondence**

Mazziott, Joseph - Training Licenses - Allow our residents the same access to GA Training licenses as they would a request from a GA based Residency. Allow the training license to extend to a full year time limit rather than 3 months.

Response: Georgia Composite Medical Board will require Residency Training Permits

Montana, Eduardo - Institutional Physician License Petition - Petitioning the GCMB today to consider instituting the recent Tennessee legislation by Gov. Bill Lee signed into law April 6, allowing international medical graduates to bypass U.S. residency training and enter practice as a licensed physician.

Response: Institutional Licenses are issued by the Georgia Composite Medical Board allowing IMG's who have not completed U.S. residency training to practice medicine.

Braun Internal Medicine GA/SC State Line - Located in Pooler, GA receives inquiries from SC residents who would like to become patients of the practice. Braun has a GA license only. Can Dr Braun accept SC residents into the practice? Where can Dr Braun find on the regulation that covers the above situation?

Response: No issues with SC residents who would like to become his patients. The Medical Practice Act of Georgia contains the information on this subject. Check with the SC Medical Board for information for their requirements.

**NURSE PROTOCOL ADVISORY COMMITTEE REPORT**

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Marshall seconded. The motion carried unanimously. The Board took the following actions:

Questions:

- Ashlie Malone – Clarification for a Georgia-licensed APRN regarding her desire to own and open a MediSpa  
Response: No, it is out of the realm of practice for Physicians to engage in this type of arrangement. Physicians cannot be employed by the nurse that they are delegating.
- Kimie Buley – Georgia NPs performing tunneled central venous line insertion  
Response: With proper training and an approved Form C, the Board would consider allowing an APRN to conduct this procedure.
- Mariana Hankins – Podiatrist delegating to MD  
Response: The agreement needs to be between the MD and the Nurse. The Podiatrist cannot delegate to the APRN nor can they be the supervising physician.
- Rachel Durso – APRN being denied for inpatient work without Acute Care certification  
Response: Yes. The Board reviews comparable specialties and the submitted CV in order to determine each Protocol Agreement on an individualized basis.
