2. Other Business:

The Committee expressed concerns regarding Clinical Perfusionists who have not submitted their application as of 12/31/03, and who may be practicing without a State of Georgia license. There were also suggestions as to how this information can be provided to hospitals. One recommendation was to request the assistance from the Georgia Hospital Association (GHA) in relaying this information to Chiefs of Staff in hospital facilities.

The Board also decided to post the licensing requirement of Perfusionist in the Board's newsletter and to notify companies who employ Perfusionists.

LICENSING COMMITTEE MATTERS

Dr. Cheeks presented the report of the Licensing Committee that met on Thursday, January 8, 2004. Dr. Summers moved to approve the committee's recommendations, Rhonda Kunes seconded, and it carried unanimously. The recommendations were as follows:

- 1. The Committee considered correspondence from Pat McGraw, asking if pathology residents from the Baptist Health System in Birmingham, Alabama need to be licensed to work a month or two at Emory University Hospital. Dr. Kamath moved that the residents would need to be licensed if they did not fall within the two (2) year exemption that is provided by 43-34-26. Dr. Hill seconded the motion and it carried unanimously.
- 2. The Committee then considered two waivers of the (7) seven-year rule to pass all three steps of USMLE from David Y. Yi and Elizabeth Sirota. Dr. Finely moved that both requests be denied because they failed to establish significant, unique and demonstrable legal hardship. Dr. Kamath seconded the motion and it carried unanimously.
- 3. Dr. Hill made a motion that all applicants who are licensed in another state and have taken longer than seven (7) years to pass all three steps of USMLE or have taken Step 3 more than three (3) times should be bought to the Committee for review. Dr. Finley seconded the motion and it carried unanimously.
- 4. The Committee considered the following questions from the staff: Is a letter of good standing from the Program Director where the Postgraduate Training was completed, acceptable for an applicant to get a temporary license, if the following occurs?
 - a. International Medical School Graduate (IMG);
 - b. Completes the three-year program on a date prior to the diploma date, (i.e., completes program technically on June 14, 2004 but the certificate date reports June 30, 2004);
 - c. has to start a fellowship on July 1, 2004 and the meeting is scheduled most often after the July 4th holiday;
 - d. has an application which requires no committee review;

- 5. Is a letter of good standing from the Program Director where the Postgraduate Training was completed, acceptable for an applicant to get a temporary license, if the following occurs?

 - b. Completes the residency program on a date prior to the diploma date, i.e., completes program technically on June 14, 2004 but the certificate date reports June 30, 2004;

REASON: Fellowships which begin on July 1 and a contract is signed to begin that date but applicants cannot until the PGT form is received indicating completion of training. This most often occurs with IMG applicants.
