- **Gilormo Injury Law: Inquiry on alcohol and med spas**; The Georgia Composite Medical Board reviewed your correspondence and recognizes and supports the position of the American Academy of Dermatology on this subject.
- **Miller & Martin**: Use of naturopathic methods in Georgia. The Board recommends the following:
 - Naturopathic practitioners should identify themselves as such when interacting with patients.
 - Be aware of O.C.G.A. § 43-34-22(a) when using the term “doctor.”
 - There are no laws or rules prohibiting a naturopathic practitioner from working alongside a physician. However, the physician is responsible for a patient’s care.
 - The Attorney General’s opinion on this matter can offer additional guidance as well.
- **David Retterbush, MD**: FY24 contract as an assistant medical director
- **System Automation Corporation**: FY24 contract for software services
- **CE Broker**: FY24 contract to assist licensees with free compliance for the Board’s continuing education requirements.

NURSE PROTOCOL ADVISORY COMMITTEE REPORT

Dr. Gross presented the APRN Committee Report as a motion. Dr. Gangasani seconded. The motion carried unanimously. The Board took the following actions:

The Committee recommended the following:

1. I am a law clerk at ByrdAdatto in Dallas, TX. I had a question regarding Nurse Protocol Agreements in Georgia I was wondering if you could give more guidance on. I understand that pursuant to Rule 360-32-.05, a delegating physician to an NP must maintain a record of on-site observation and review of medical records on a quarterly basis to monitor the quality of care being provided to patients. However, if an NP is exclusively providing telemedicine services, they do not have a physical location. So, how would the physician meet the quarterly onsite observation requirement? May they conference into the telemedicine appointment, or must the physician be physically present with the NP when telemedicine is being provided? **The rule says onsite observation.**
2. Could you please clarify the regulations regarding a collaborative agreement between a Georgia physician and an APNP when we both work remotely?
I am a physician licensed to practice in Georgia. I work for a telehealth company with offices in Atlanta, but I live in Colorado and practice remotely. Likewise, the APRN is licensed in Georgia but works remotely from her home. Does Georgia law allow for a collaborative agreement given that we do not physically work out of the same office? **Cannot be a supervising physician for a Nurse Practitioner seeing patients in GA.**
3. I am writing to seek clarification on the application of rule 360-3-.07 or .06 in the Georgia state laws with regard to electronic visits and the ability of a provider to prescribe controlled substances. Our team has been reviewing the current regulations and is particularly interested in understanding whether a telehealth visit conducted by a physician, PA, or APRN with the help of a telepresenter would meet the requirements for prescribing controlled substances if all other relevant rules are adhered to. We have also taken into account the proposed rules by the Drug Enforcement Administration (DEA) regarding qualifying telemedicine referrals.

Given the importance of providing accessible healthcare services, especially in light of recent advancements in telemedicine, we believe it is crucial to have a clear understanding of the regulations in order to ensure compliance and deliver the best possible care to our patients.

Therefore, we kindly request your guidance on the following questions:

1. Does Rule 360-3-.07 or 360-3-.06 in the Georgia state laws preclude prescribing controlled substances after or due to an electronic visit from an MD? **Refer to Rule 360-3-.07 or 360-3-.06.**
2. Does Rule 360-3-.07 or 360-3-.06 in the Georgia state laws preclude prescribing controlled substances after or due to an electronic visit from an APRN or PA? **Refer to Rule 360-3-.07 or 360-3-.06.**
