1. Patel, Kosha - I am reaching out for some clarity on the GA medical board rules. Specifically, I'm looking to learn whether GA requires foreign PC shareholders who are not practicing in the state to be licensed in the state. The blue highlighted language below suggests to me that foreign PC shareholders should be GA-licensed; however, the yellow highlighted language is broad and could mean the as long as the GA medical board permits it, out-of-state shareholders are okay.

O.C.G.A. § 14-7-2 “Licensed” includes registered, certified, admitted to practice, or otherwise legally authorized under the laws of this state by the appropriate regulating board.

O.C.G.A. § 14-7-4(b-c) A professional corporation shall engage in the practice of a profession only through its officers, employees, and agents who are duly licensed or otherwise legally authorized to practice the profession in this state.

O.C.G.A. § 14-7-5(a) Shares in a professional corporation may only be issued to, held by, or transferred to a person who is licensed to practice the profession for which the corporation is organized . . .”

Any guidance you can provide here would be greatly appreciated.

RESPONSE: Title 14 is not a title that the Georgia Composite Medical Board provides clarification on, therefore, PC Shareholders should consult with their own attorney.

2. Weinbaum, Cindy – Administrative licensee is seeking to reenter clinical practice and enroll in the Physician Retraining and Reentry course with UC San Diego School of Medicine. Would the program be sufficient to apply for a clinical Georgia physician license?

RESPONSE: Once the Physician Retraining and Reentry program is completed, have the program send all records to the Georgia Composite Medical Board for review, at which time a determination will be made on conversion of the Administrative License to an unlimited Physician license.

- b. Collaborating Docs – matching NPs with collaborating physician - Information Only
- c. Correspondence from Laurie Ray regarding exception for ultrasounds being read by APRNs who are working within their scope of practice.
RESPONSE: Staff will need to update the template to include the exception as stated in O.C.G.A. § 43-34-25(c)(3) which reads “...except that such provision for an ultrasound shall not be required for an advanced practice registered nurse acting within his or her scope of practice as authorized by Code Sections 43-26-3 and 43-26-5.”
- d. Correspondence from Roselyn Anukam regarding the collaborative physician needing to evaluate or examine any patient prescribed a controlled substance on a quarterly basis or more frequently. The question was is a chart review sufficient.
RESPONSE: No, a chart review is not sufficient to meet the requirements as set forth in O.C.G.A. § 43-34-25(c)(9).
