Questions and/or Action Items

- <u>Aaron Chase, LLC</u>: "As a practical matter, what does a doctor's office need to do in order to establish a provider-patient relationship via telehealth?" For example, can the doctor's office establish the relationship using an online questionnaire? Or is a real-time audio-visual (e.g. Zoom call) experience required? After discussion, the Board would like to refer to the existing rules concerning this matter (Rule 360-3-.07). Specifically, subsection (a)(3) addresses four scenarios for how a Georgia-licensed physician, physician assistant, or advanced practice registered nurse would practice through electronic or other such means. https://rules.sos.state.ga.us/GAC/360-3-.07
- <u>Georgia Board of Health Care Workforce</u>: MOU on data sharing. The Board voted to share this information and enter into the agreement. Motioned by Dr. Gross, seconded by Dr. Marshall.
- <u>System Automation</u>: Contract for Verification API (Application Programming Interface). Dr. Marshall motioned, seconded by Dr. Reisman to <u>enter into the</u> <u>contract</u>.

- <u>Georgia Nonpublic Postsecondary Education Commission</u>: Question about Composite Board Oversight. It was stated that the Medical Board cannot grant an exemption that would override the rules/laws. Dr. Gross motioned, seconded by Dr. Reisman.
- <u>Barbara Rogers</u>: Does "(1) the physician [have to] remain on site when the RN is injecting, and (2) what the definition is of a 'written order'"? As noted in the FAQs on the GCMB's website, RNs do not have prescriptive authority but can inject with appropriate training and a written order from a physician. The physician should examine/prescribe, but the physician does not have to remain on-site while the RN is injecting pursuant to a written order. A "written order" means to prescribe which drug, medical device, medical treatment, diagnostic study, x-rays, ultrasounds, or medical imaging is appropriate for a patient and to communicate the same in writing, via facsimile, or electronically. This document should include details about what was ordered by a patient's treating/prescribing physician.

CLOSED SESSION

NURSE PROTOCOL ADVISORY COMMITTEE REPORT

Dr. Norman presented the APRN Committee Report as a motion. Dr. Bhat seconded, and the motion carried unanimously. The Board took the following actions:

Questions

1. I have a new Medical Director and I currently work at a weight loss clinic. We were trying to clarify a couple of things and could not narrow down a direct answer from the nurse protocol information/agreement. My Medical Director requested that I obtain clarification of the following:

a) It states in our agreement that our Medical Director will review at least 10% of my charts. He asked -is he required to document somewhere in the chart that he reviewed -such as adding an addendum, or is it understood that he will automatically audit the 10% of charts and advised me of any issues found? **Yes, there must be documentation.**

b) I review basic labs of our patients such as CMP and CBC. Is my Medical Director required to review or sign off on all the labs or is it okay for me to review and sign off on the labs -as he will be auditing charts. **No**

c) Is my Medical Director required to sign every chart I complete? Or do I just sign off on them? Please advise. We do prescribe Phentermine for weight loss to some of our patients. **No, you sign off on your own.**

- 2. a) Do the geographic restrictions for supervision set forth in O.C.G.A. § 43-34-25(a)(12) apply when the services are provided via telemedicine? In other words, if a physician is licensed in GA, but physically located outside of the state, may the physician supervise a GA licensed APRN or PA providing telemedicine services to patients located in GA? **Yes, the geographic restrictions apply.**
 - b) Does the APRN or PA providing telemedicine services need to be physically located in GA when the telemedicine services are provided? The rule does not say the APRN has to be physically located in Georgia.
 - c) May APRNs prescribe controlled substances via telemedicine? Please be guided by federal rules and regulations around controlled substances and telemedicine.
 - d) The Medical Board's <u>FAQ</u> for Protocol Agreements notes that the maximum number of APPs a physician can supervise is determined individually by each type of advance practice provider and that a physician could have up to eight (8) advance practice providers (4 APRNs and 4 PAs) at one time. Are the applicable statutes and regulations appropriately interpreted as allowing a combination of APPs as long as the combination does not result in more than four (4) APRNs and four (4) PAs? In other words, a physician could not supervise six (6) APRNs and (2) PAs? The physician can have a maximum of four each.
- 3. I am a Nurse Practitioner; I have changed my primary state of residency to GA therefore I had to change my NP license number. My old NP License number was GAA-NP. My new NP license is #RN. I already have an approved protocol agreement under the GAA-NP number. **My question to the composite medical board is:**

Can you please amend my existing protocol agreement to reflect my new NP license # or do I have to be resubmitted for a new protocol agreement? **Resubmit the protocol agreement with the new RN number.**

I do not want to apply for my DEA with my old GAA- NP license number as I am now working under a new license number. If something were to happen, I do not want to get into any trouble with the Medical Board due to prescribing narcotics with a different license number than the one I am using to practice.

The credentialing specialist at my office has not received an answer regarding this matter after asking for quite some time.

To reiterate, do I need to request a new protocol agreement with my new number, or can the composite medical board make an amendment to my existing protocol? My sponsoring physician and all other information will remain the same.

4. I noticed some rules and regulations have been updated in 2023.

https://law.justia.com/codes/georgia/2017/title-43/chapter-34/article-2/section-43-34-25/ I am a CRNA (advanced practice nurse who specializes in anesthesia) who also does injectables (neurotoxin, filler, etc.). I have been trained extensively to provide these services. My medical director (ER physician) has also been educated and trained on these services. We have a nurse protocol agreement and standard operating procedures manual. Does this need to be approved by the composite medical board? If so, how do we do that? Is anything else required as a CRNA to inject? So long as you are not prescribing, a protocol agreement does not need to be on file with the GCMB.
