1. Correspondence from Derrell Leggett, MD
Board Response: Georgia Law does not allow for pain management treatment via telemedicine; however, the DEA has extended the telemedicine flexibilities for controlled substance prescriptions through December 31, 2024. Practitioners engaging in pain management treatment must still comply with all aspects of Board Rule 360-3-.06.

PHYSICIAN LICENSURE COMMITTEE REPORT

Discussion:

Ms. Emm requested to speak with the Committee on petitions to waive Rule 360-2-.02(6), which states “**Applicants who have never been licensed**, and who have failed the USMLE Step 3 a total of three (3) times since January 1, 1994 must have one year of additional Board-approved clinical training. The training must be completed prior to taking USMLE Step 3 again.” Emphasis added. Ms. Emm pointed out that this rule does not apply to applicants already licensed in other states. Moving forward, if an applicant is already licensed in another state and it took more than three attempts to pass Step 3, they do not need to submit a rule waiver for this rule. The Committee agreed that such petitions would be moot.
