**EXECUTIVE DIRECTOR'S REPORT**

Mr. Dorsey shared updates from the Federation of State Medical Boards:

- LaSharn awarded the Lifetime Achievement award.
- Permitting out of state practitioners to provide limited care in certain situations was not adopted.
- Supporting the development of regulatory innovations in license portability was adopted.

Mr. Dorsey shared a letter from St. George's University in Grenada regarding ownership interests of the school.

Mr. Dorsey also shared a report from the Georgia PHP regarding physician health programs and the equivalence problems.

Mr. Dorsey also provided an update regarding the rules and the resubmission of all items from the past seven months.

Mr. Dorsey also presented a request for GCMB position/advisory opinion from the law firm Law Offices of Gregory A. Zitani, PLLC:

- QUESTION: Can physicians prescribe certain passive modalities and active rehabilitation services, that will be performed in-office, by medical assistants if the physician or an appropriately supervised physician extender, i.e. PA or NP, remains on-site one hundred percent (100%) of the time any services were provided by the properly trained medical assistant? ANSWER – The Board voted to ask for more clarification.

Mr. Dorsey also presented an open records request from Mike Hostilo Law Firm: DECISION: The Board voted to provide the open session minutes from both the full Board and the physician licensure committee meeting.
