**CORRESPONDENCE AND DISCUSSION ITEMS**

- a) Correspondence from Janet Markle, MD

Dr. Markle inquired whether the course she must take as a VA system physician would count towards the mandatory CME hours required by O.C.G.A. § 43-34-11(a)(6) regarding professional boundaries and physician sexual misconduct. Dr. Markle also inquired about the frequency of the mentioned requirement and of the opiate prescribing training requirement.

Board Response: Pursuant to O.C.G.A. § 43-34-11(a)(1), the Board is authorized to approve courses offered by institutions of higher learning, specialty societies, or professional organizations. Pursuant to Board Rule 360-15-.01(2), the Board accepts CME approved by five providers: American Medical Association, American Osteopathic Association, American Academy of Family Physicians, American College of Obstetricians and Gynecologists, and American College of Emergency Physicians. The VA training course, as indicated in the correspondence, is not approved for CME hours. The Board is requesting a copy of the training for review.

As it relates to frequency, the professional boundaries and sexual misconduct requirement is one time only. It was unclear in the inquiry if the inquirer was asking about Board Rule 360-15-.01(3) or (4), clarification will be necessary.

- b) Correspondence from Jeffrey Haworth

Mr. Haworth has asked for the Board's position on the practice of paramedics, under the supervision of a licensed physician, to practice within the Georgia EMS Scope of Practice while providing mobile health and wellness services. Such services would include history taking, physician examination, intravenous therapies, lab draws for shipment to an accredited laboratory, and telehealth facilitation under the supervision of a physician medical director with Hydreight that would provide medical oversight for the non-ambulance related medical activities of our company.

Board Response: The Board stated that the above listed functions are not emergency services, and such functions would constitute the practice of medicine.

**NURSE PROTOCOL ADVISORY COMMITTEE REPORT**

Dr. Cheek presented the APRN Committee Report as a motion. Dr. Bostock seconded. The motion carried unanimously. The Board took the following actions:

Correspondence

- a) Shavon Hamilton: Inquiring whether based on the updated position statements posted by the Georgia Board of Nursing, if prescriptive authority and cosmetic and aesthetic procedures are now available for CRNAs.

Response: Based on an evaluation of O.C.G.A §§ 43-26-11.1 and 43-34-25, as well as Board of Nursing Rule 410-11-.04, prescriptive authority and cosmetic and aesthetic procedures would be outside of the scope of practice of a CRNA.

- b) Autumn Lucas: Inquiring about delegating physician limits for a public university campus health clinic and malpractice when supervising APRNs in a different facility or setting from the physician's place of primary employment.

Response: Please see O.C.G.A. § 43-34-25(g), the language was changed as of July 1, 2024, to read a delegating physician may not enter into a nurse protocol agreement pursuant to this Code section or enter a job description with a physician assistant pursuant to Code Section 43-34-103 with more than the combined equivalent of eight advanced practice registered nurses or physician assistants at any one time. Also, note, (g)(2) provides an exception for APRNs practicing "in any college or university as defined in Code Section 20-8-1." As for the malpractice, the delegating physician would need to contact their carrier directly to determine coverage requirements.
