Response: There is nothing in the rules that speaks to a grace period for such occurrences. The designated physician can step in, if there is one on the agreement. However, if there is none, the APRN cannot prescribe until there is a new protocol agreement in place. The APRN will only be able to carry out their nurse duties during that period.

Angelina Lee: Question as to whether an FNP would need Form C to perform shave and punch biopsies, suturing, and I&Ds.

Response: The procedures listed are within the scope of practice of a nurse practitioner and therefore a Form C would not be required.

- b) Correspondence from Seth Enterline regarding physician cosigning charts for controlled substances.  
Response: The Board had not set a chart co-signature requirement on PAs for patients are receiving controlled substances III, IV, or V. If the facility requires a co-signature, then the PA and physician must abide by the facility's policies. The law and rules require that the supervising physician (primary or alternate) examines every patient that is receiving a controlled substance at least once every three months.
