Does loco parentis under GA Code § 31-9-2 (2022) extend to stepparents, parents without legal custody such as non-legitimized fathers, and other persons who bring the patient in for care

- b) Correspondence from Kirk Shook, Executive Director, Georgia Nonpublic Postsecondary Education Commission requesting review of Trichology Proposed Program Guidelines used for unaccredited programs.
