5. In addition to the hours of continuing medical education required to be eligible for each renewal, Respondent should complete 20 hours of CME in the area of ethics before petitioning for lifting of the suspension.
6. Respondent shall pay the administrative cost of the instant action prior to being eligible to petition for lifting the suspension, which costs amount to \$2,500.00
7. Respondent shall continue to pay the license renewal fee by or before the expiration date of his license.
8. Respondent shall abide by all State and Federal laws.
9. Upon the filing of a petition to lift the suspension by Respondent, Respondent may be required to appear before the impairment committee. Respondent must demonstrate that he is able to practice medicine with reasonable skill and safety to patients. The Board may require Respondent to sit for and pass an examination such as the SPEX, prior to the lifting of the suspension. The Board shall have the discretion to lift the suspension, to place any conditions or restrictions on Respondent's license, or to deny the petition. If the petition is denied, Respondent may request an appearance before the Board but not as in a contested case.

Dr. Walden moved to approve a letter from the Board to Orthotist and Prosthetist informing them of licensure provisions of the Orthotics and Prosthetist Practice Act which will become effective July 1, 2006. Dr Summers seconded and it carried unanimously.
