**CHAIR'S REPORT**

Dr. Gangasani reminded Board members about recusal packets and took a headcount for the October 3, 2024, meeting, which will be held in-person at the Mercer campus in Columbus, Ga. The last two meetings of the year are November 7<sup>th</sup> and December 5<sup>th</sup>. The proposed 2025 meeting dates will be shared with the Board soon for review.

**EXECUTIVE DIRECTOR'S REPORT**

Mr. Jones shared updates that were for information purposes only.

**CORRESPONDENCE AND DISCUSSION ITEMS**

1. Correspondence from Chris Kim, MD – Can an oral surgery residency count towards required CME for his physician license.  
Response: No, the licensee would need to complete required CME as a dental residency does not qualify as CME.
2. Correspondence from Kevin Rew, Esq. – For nurse practitioners practicing under O.C.G.A. § 43-34-23 protocols, are physicians bound to the same delegation limits and location requirements?  
Response: Yes, physicians should abide by the same ratio and location requirements as O.C.G.A. § 43-34-25 protocols.
3. Correspondence from Mike Lewen – Does the state allow non licensed individuals (or certified personal trainers) to use diagnostic ultrasound for diagnosing osteoporosis or osteopenia through Bone Mineral Density (BMD) measurements and their subsequent T/Z scores like that of a DEXA to sell exercise/training memberships?  
Response: Non-licensed individuals are not permitted to diagnose, such would be considered the unlicensed practice of medicine. Please see O.C.G.A. § 43-34-22.
4. Correspondence from Tarun Singh – Does Georgia require a UDS test when prescribing controlled substances (such as Suboxone) to patients? If yes, how frequently are UDS tests required? Does the UDS test need to be monitored?  
Response: Please see Board Rule 360-3-.06 and SAMHSA guidelines. Yes, a UDS would need to be monitored.
5. Correspondence from William G. Carson Jr., MD – Can a physician order an in-office MRI and read/interpret the results without review by a board-certified radiologist?  
Response: There is no law or rule that would prohibit a licensed physician from ordering and reading an MRI scan.
6. Correspondence from Charmaine Mech Aguirre, Esq. – Situation: A physician assistant will be the sole owner of a legal entity that owns and operates an urgent care center in Georgia. The operating entity of the urgent care will employ physician assistants and nurse practitioners. The PA owner will practice at the urgent care. The operating entity would like to engage a physician to act as medical director who will have administrative duties and supervision of the PAs and NPs, including the PA owner. The operating entity wants to engage the physician as a 1099 independent contractor and pay a fair market

value hourly rate for services. The purpose of engaging the medical director is to satisfy the Board's supervision requirements. The agreements will be between the operating entity and the physician, not the PA owner and the physician. Does this comply with the law?

Response: Table for further research.

Zachary F. Solomon, MD appeared before the Board with his attorney, Frances Cullen, Esq., to appeal the Board's decision to deny his reinstatement application for a physician license based on a felony conviction.

Dr. Flint made a motion, seconded by Dr. Norman, to uphold the denial. The motion carried unanimously.
