Mr. Dorsey also shared the following action items:

- **Emory** – If a patient has been seen by a member of our palliative medicine practice inpatient and has been prescribed opioids and the patient is discharged to the outpatient setting to follow-up in our clinic, can the outpatient provider (who is not the same as the inpatient provider but is in the same palliative medicine practice physician group) prescribe opioids via telemedicine in follow-up? **If someone has seen the patient within a reasonable time frame and there are duplications regarding overprescribing, then yes.**
- **Emory** – If a patient has been seen face to face inpatient by a member of our palliative medicine practice and is subsequently seen by an outpatient provider in our practice via telemedicine, can the inpatient visit by our provider count as a face-to-face visit and our outpatient provider prescribe opioids via telemedicine? **If someone has seen the patient within a reasonable time frame and there are duplications regarding overprescribing, then yes.**
- **The Longstreet Clinic** - Clarification of the definition of a “licensed health care practitioner,” as noted in the Office-based Anesthesia & Surgery Guidelines / Rules. **Refer to O.C.G.A 43-34-47.**
- **David H. Moskowitz, LLC** – Request for advisory opinion regarding telemedicine practices. **Declined to answer.**

- **Amy Pearson, MD** - I am an interventional pain physician in private practice in Georgia (no narcotics) and am looking to add a Medray Accu IV Class IV infrared therapeutic laser for pain relief. This laser gently heats the deep tissue and increases blood flow, thereby helping with inflammation. Would the employee administering the laser treatment require any special licensure? **If the employee is an APRN, a form C will need to be submitted to and approved by the Board. If the employee is a Physician Assistant, an additional duties document will need to be submitted to the Board. A physician is allowed to use the device at their discretion. Any energy emitting device that's not specifically covered by the law can be considered a practice of medicine therefore the employee should be licensed and there should be a physician onsite when the device is being used.**

- Feedback on tentative calendar for 2023: **The Committee agreed to the following changes: March 30th, April 27th instead of May 4th, May 25th instead of June 1st, June 29th, and August 31st instead of September 7th.**

- Feedback on ceasing to print paper copies of the license and allow licensees to download a pdf copy of the license from their online account. **The Committee agreed to cease the production of paper copies.**
