QUESTIONS, ACTION ITEMS, AND/OR DISCUSSION

1. **Dr. Kilee Smith**: Request for guidelines/rules for infusion center exams. **Response:** At its recent meeting, the Board discussed your correspondence below. The Board has stated that a “good faith exam” is no different than any other patient exam you conduct. All examinations must be performed in accordance with the laws and rules and must be appropriately documented, as such creates a physician-patient relationship.
2. **Drug Enforcement Administration**: Prescribing controlled substances via telehealth. **Response:** The Georgia Composite Medical Board voted during its December 2023 meeting that effective Jan. 1, 2024, the Board's previous position on the flexibility allowed through the Drug Enforcement Administration's telehealth prescribing policy during and after the COVID-19 pandemic will be rescinded. All licensees should refer to the *Medical Practice Act* and Board Rules for proper prescribing practices in Georgia.
3. **Krista Cooper (w/ Bass, Berry & Sims PLC)**: Telemedicine for controlled substances prescriptions. **Response:** The Board considered the DEA Extension again at its meeting last week. Please review the public posting on the Board’s website: <https://medicalboard.georgia.gov/press-releases/2023-12-07/board-updates-position-telehealth-prescribing>.
4. **Lanchi Bombalier (w/ Arnall Golden Gregory LLP)**: Out-of-State Physician Orders for Home Health Services Provided to Georgia Residents. **Response:** At its recent meeting, the Board discussed your correspondence regarding out-of-state physician orders for home health services provided to Georgia residents. The Board stated that a Georgia license would be required to engage in such practice. The Georgia Composite Medical Board offers multiple paths to licensure, including telemedicine licensure.
5. **Chet Bhasin (w/ Georgia Board of Health Care Workforce)**: Ad hoc request for physician data. **Response:** The Board discussed your correspondence and denied the request.
