### Questions and/or Action Items

- **Walmart Pharmacies:** Walmart is contracting with a new standing order physician for our immunization standing order. The standing order physician works full time from home in a telemedicine practice (Nadine Regis, NPI [REDACTED]). Would there be any concern with contracting with her since she is a full-time telemedicine physician? Would there be any concern with listing her home address on the protocol?
- **There is no concern from the Board with having a telemedicine physician listed on the protocol.**
- **There is no concern from the Board with listing the physician's home address on the protocol. However, the physician may have concerns herself with listing the address.**
- **Other considerations voiced by Board members.**
  - **The physician should meet all qualifications to enter into a protocol as defined in Rule 360-34-.02:**
    - **Hold a current license to practice medicine in the State of Georgia.**
    - **Have his/her principal place of practice in the State of Georgia.**
    - **Be registered with the Georgia Registry of Immunization Transactions and Services ("GRITS").**
    - **Not be employed by the pharmacist(s) or nurse(s) with whom he/she is entering into the vaccine protocol agreement.**
    - **Not be an employee of a pharmacy that also employs the pharmacist(s) or nurse(s) with whom he/she is entering into the vaccine protocol agreement; and**
    - **Be available for immediate consultation or have designated another qualified physician as an alternate physician who is available for immediate consultation.**

  - **The physician should understand the risks/benefits/side effects of vaccinations and be able to communicate with patients and pharmacists/nurses (as needed), especially if there is an adverse reaction.**
  - **The physician is ultimately responsible for patient outcomes of a pharmacist/nurse carrying out the vaccine order.**
  - **The same limitations to the physician apply to a vaccine protocol agreement, as defined in Rule 360-34-.06:**
    - **The physician shall not enter vaccine protocol agreements with more than ten (10) pharmacists and/or nurses except as provided in O.C.G.A. Section 43-34-26.1(j).**
    - **The physician must be in the same public health district as the nurses identified in the protocol; or the nurses are located in the same or contiguous county as the physician's registration with the vaccination registry.**
    - **The physician shall have verified that the pharmacist(s) or nurse(s) have had Basic Cardiac Life Support training and any other training required by law.**
    - **The physician shall verify that the pharmacist or nurse administering the protocol has policies and procedures for the handling and disposal of contaminated equipment and supplies.**
