The Board voted to table this correspondence for additional consideration.
2. Hannah Moore, Williams Mullen: The Board discussed correspondence requesting clarification of O.C.G.A. § 43-34-31(a), which states in part “Any such out-of-state or foreign practitioner shall not have ultimate authority over the care or primary diagnosis of a patient who is located in this state.” Does this mean that an out-of-state provider, even if licensed in Georgia, cannot be a patient’s primary care provider? Does the out-of-state provider need to be connected to an in-state provider, or does the patient just need to have a separate primary care provider within the state? The Board directed staff to respond that this is currently how the statute reads, so this is the current law in Georgia.
In addition, the Board requested that staff reach out to the Governor’s Office and General Assembly regarding the options to clarify this statute.
