EXECUTIVE DIRECTOR'S REPORT

Ms. Hughes gave the following report

Staff Recognition:

Ms. Hughes recognized Ms. Phyllis White for completing the Emerging Leaders training. She also recognized Mr. Jonathan McGehee for graduating from Chief school.

GOMA meeting and the Chaperone Rule – couple of questions – What happens if the patient refuses a chaperone – how to handle? What is a member of the opposite sex now? The Board will review the rules for clarification.

Rules Waiver – Megan Smith – problem with Form B RCP. The Board approved the waiver, Ms. Smith provided a substantial hardship.

Compact Problems – with FBI background checks. Working with AG and the Compact to resolve the problem, may need legislation to fix.

G. Michael Duffell, MD – asking for an exemption of CME. The Board denied the request.

Grace Foster – asking if there is an alternate to prescribing opioids – considering CBD oil. The Board does not have a Rule or policy on this matter.

FSMB on physician re-entry. “Stepping away from your clinical career.” The Board asked the staff to share with professional associations and publish in the newsletter.

Radiology Assistant, what duties can they perform. Duties are outlined in the Laws and Rules.

Regina Adams – requesting the Board send another state proof of her RCP education. The Board approved the request if one is available.

Britt Thames – email regarding – Offsite Medical Director for a facility that does IV injections of vitamins. Must have the appropriate medical personnel such as APRN, PA or physician to evaluate the patient.

Greg Gaylis – email regarding Electronic Prescriptions re Pain Management and Telemedicine.

Georgia Williams – in the state of Georgia is a licensed acupuncturist licensed to inject materials into a patient? Not allowed to give injections, unless a physician acupuncturist.

Assistant Physicians – There was a proposal from Medical Association of Georgia to license a category of licensure for assistant physician, which will assist physicians in their practice. The Board voted not to support this legislation.

Ann Purcell – Our Texas entity is owned by physicians with Texas medical licenses. Those owners would not provide medical services in Georgia. The owners of the entity would not be required to obtain licensure in Georgia as long as they are not seeing or treating patients in Georgia.

Sherrice Hodge, My question is regarding body contouring. Is a license required to perform non-invasive laser lipo? What are the requirements to operate this type of business? At this time this is not addressed in the law, but the Board considers this a medical procedure.

NURSE PROTOCOL ADVISORY COMMITTEE

Dr. Gross presented the Nurse Protocol Report:

The Board took the following actions:

Other Business

1. Does a NP needs a collaborating/supervising physician when conducting research/performing physicals for clinical trials, mainly as a sub-investigator. These are patients who have agreed to be a part of a study mainly testing new drugs from pharmaceuticals and the DEA. These patients have signed a waiver. **If the APRN is prescribing the answer is Yes, If not the answer is No.**
2. I know that radiographic imaging includes x-rays, CT scans and MRIs, but do ultrasounds and mammograms also fall under radiographic imaging for the purposes of the regulation of APRNs? **In life threatening situation ONLY.**
3. If a delegating physician leaves our practice and decides to stay on PRN (temporary, as needed) can this physician continue to be a delegating physician on a protocol agreement with our mid-level (NP)? **Agree to 50 miles within the protocol and delegating Physician comply with protocol.**
4. **I am currently an APRN in Georgia** and practice as a CRNA and have for almost 20 years. I recently had to opportunity presented to me to deliver BOTOX and dermal fillers in a spa. There is a Ga physician who will be my sponsor for medication ordering and be the medical director over the spa. My question is what do I have to do in order to start the process of administering Botox and dermal fillers? The Ga Physician will not be onsite, so would a protocol that he approves be enough for this situation? And will he need to sign the charts-H&P and procedure note? And if so, will he need to sign all of them or just a portion? Or does he need to review a certain percentage of them? Would a signature stamp be enough, or does he need to sign each one? **Form C and protocol, review 10% of charts by Delegating.**
5. I am a psychiatrist in private practice and have a question and request regarding the limit of APRNs that one physician can supervise and serve as the delegating physician for. **The answer is No. 4NP and 2 PA's**
6. I am trying to clarify what the rules are in the event that my delegating physician has resigned. **NP has 60 days to present a new protocol.**
