QUESTIONS/REQUESTS

F. Ramzi Asfour, MD - Independent Insurance Medical Exams

Question: Is a Georgia medical license required for a physician to do an independent medical exam for an insurance company in the state of Georgia?

Response: Yes, a Georgia license is required for patients in Georgia.

Milada Goturi - Thompson Coburn, LLP - Out-Of-State Physician Consultation

Question: Scenario

1. GA patient being treated by GA physician, and
2. GA physician seeks consultation with Out-of-State physician regarding the GA patient's case/condition. Is Out-of-State physician required to hold a GA license if:
 - patient is not present for physician-to-physician consultation.
 - patient is present for physician-to-physician consultation.

Response: As long as the consulting physician only provides such requested consultations on an occasional basis, is not the physician of record in making the diagnosis or generating the treatment plan, and the consulting physician is not billing for services, they do not need a GA license in either scenario. This should be documented in the record.

Question 1: Could GCMB consider the one year of training on a non-ACGME program (accredited by AUPO) as proof of US medical training for the purpose of a full license to a FMG? Response: No

Question 2: As having passed the ECFMG tests in 1993 and 1995, could the GCMB consider a waiver on the step 3 requirement, and evaluate the reports of those examinations to meet the requirements for licensure? Response: No

Question 3: If I obtain an institutional license during this year of training, would it prevent me getting an unrestricted license after one year, even being certificate from the fellowship program? Response: Yes, you can apply for an Institutional License and pass Step 3 then within a year or two apply for full license with training program letter indicating competency to practice independently.

Questions:

1. A.P asked what is required for a particular position at a IV Hydration clinic.

Committee's response: The APRN just needs a collaborative practice agreement.

2. J.M had questions about the nurse protocol scope of practice.

Committee's response:

- i) The specialties need to be similar.
- ii) If the APRN has previously been approved by the GCMB to perform the procedure under an old delegating physician, a copy of the GCMB's approval letter may be submitted in lieu of procedure logs. The Board's approval of a Form C is not automatically transferrable from an old delegating physician to a new one, so the APRN will still need to apply for Form C under the new delegating physician (just without the procedure logs).
- iii) The physician must be competent in whatever procedures the APRN is doing. No, a certificate of completion with hands-on training by the APRN will not be sufficient.
