Key Pain requested an appearance before the Board. Their representatives made oral arguments. The Board asked questions. Dr. Retterbush motioned to go into closed session. Dr. Chandler seconded the motion and it carried unanimously.

Dr. Weil declared open session.

Dr. White motioned to license Key Pain Clinic. Dr. Powell seconded the motion and it carried unanimously.

There being no further business, Dr. Gross made a motion, seconded by Dr. Deloach to adjourn the September 11-12, 2013 Board meeting.
