CALL TO ORDER

Dr. House called the meeting of the Georgia Composite Medical Board to order at 7:30 a.m.

PASSING OF THE GAVEL

Dr. House passed the Board gavel over to Dr. Antalis.

AGENDA AND MINUTES

Dr. Weil submitted a motion, seconded by Dr. Retterbush, to approve the agenda of the July 7, 2016 meeting. The motion carried unanimously.

Dr. Wallace submitted a motion, seconded by Dr. Retterbush, to approve the minutes with amendments of the June 9, 2016 meeting. The motion carried unanimously.

CHAIRPERSON'S REPORT

Dr. Antalis presented the following items in his report:

- Reminded the Board members of their new Committee assignments for the 2016-2017 term.
- Presented a plaque to Dr. House to commemorate her service as Board Chairperson for the 2015-2016 term.

The Board took the following action:

1. Thanked Dr. House for her exemplary leadership of the Board during the 2015-2016 term.

EXECUTIVE DIRECTOR'S REPORT

Mr. Jeffery presented the following items in his report:

- Correspondence from attorney Diane J. Keefe inquiring as to whether the Board permits a physician to allow an unlicensed staff member to send to email messages to other physicians on his or her behalf, and if so, whether the Board requires the physician to complete and/or submit specific forms, or to send copies of such email messages to other parties who may be the subjects of the messages.

- Correspondence from attorney Jonathan Peters inquiring as to whether a licensee has a duty to report the payment to a plaintiff under a “high-low” agreement when there is a verdict in the defendant’s favor, and whether the Board in such case is authorized to conduct a formal investigation of the underlying matter.
- Information and discussion from Dr. Gross concerning a June 21, 2016 meeting that Mr. Jeffery, Ms. Bass, and Mr. Dorsey held with House Health & Human Services Committee Chairperson Sharon Cooper. The purpose of the meeting was to discuss the Interstate Medical Licensure Compact and how Georgia’s citizens would benefit from the state’s participation in the compact. At the meeting, Chairperson Cooper also urged the Board to require physicians to complete continuing medical education on prescribing controlled substances for pain treatment.
- An update on the Cobb County Medical Society’s newsletter article concerning the section of House Bill 1043 related to physicians’ advertisements and statements claiming specialty board certification.
- An article on how prescribing practices may be contributing to rising incidence of abuse and addiction to opiates and other painkillers.

The Board took the following actions:

1. Directed Mr. Jeffery to inform Ms. Keefe that there is currently no requirement to file any information or documents with the Board related to her inquiry, but that physicians should take care to follow all relevant laws, rules, and guidelines, including those related to the Health Insurance Portability and Accountability Act (HIPAA).
2. Upon a motion offered by Dr. Retterbush, seconded by Dr. Gross, and unanimously supported, directed Mr. Jeffery to seek the Attorney General’s official opinion on the issues raised by Mr. Peters in his inquiry concerning “high-low” agreements.
3. Assigned the Rules Committee the task of exploring the issue of imposing certain CME requirements for licensees who prescribe controlled substances for the management of pain.

EXECUTIVE SESSION

Mr. Wallace submitted a motion, seconded by Dr. Retterbush, to go into executive session to discuss investigative matters. Dr. Antalis declared the meeting in executive session. Upon conclusion of the Board’s discussion of confidential matters, Dr. Antalis declared the meeting in open session.

LEGAL / ENFORCEMENT ACTION REPORT

Karl Reimers presented the Legal / Enforcement Action Report. Dr. Gross submitted a motion, seconded by Dr. Retterbush to accept the report. The motion carried unanimously.

The Board took the following actions:

1. HERRERA, JOE, MD (physician license # 64822): agreed to a Public Consent Order containing sanctions mirroring a Florida disciplinary action, including practice restrictions.
2. MCLEAN, RONALD, MD (physician license # 30163): terminate probation.
3. TESFAYE, DANIEL, MD (physician license # 67614): agreed to public Consent Order with terms.

APPEARANCE BEFORE THE BOARD

Dr. DeLoach motioned to go into closed session. Dr. Retterbush seconded the motion and it carried unanimously.

Sharifa Abou-Mediene, M.D. requested an appearance before the Board for denial of licensure. Dr. Abou-Mediene addressed several issues before the Board and gave details pertaining to the Board's concerns. The Board members asked questions. Dr. Abou-Mediene gave information concerning her current employment and plans already in place for future employment.

Dr. Gross motioned to go into closed session. Dr. Retterbush seconded the motion and it carried unanimously.

Dr. Antalis declared open session.

Dr. Weil motioned to grant the waiver of the USMLE, request licensee take clinical skills at Board approved facility and upon completion, Board will revisit the matter. Dr. Gross seconded the motion and it carried. Dr. DeLoach opposed.

REVIEW HEARING

The Board conducted a review hearing regarding Harvey Leslie, MD initial decision by an administrative law judge. J. David Stubins, Senior Attorney General, appeared on behalf of the Board. Colette Resnick Steel, Esq appeared on behalf Harvey Leslie, MD. The Board members asked questions and reviewed the whole record and arguments made by Dr. Leslie and Ms. Steel. The Board voted to go into Executive Session to deliberate.

Dr. Downey declared the meeting in Open Session.

Dr. Weil made a motion, seconded by Dr. Retterbush, to uphold the Initial Decision of the Administrative Law Judge to limit respondent's license indefinitely in that he may not prescribe controlled substances until he has taken and passed the Merer prescribing course, at which time the Board will reconsider his prescription privileges. The Board also denied the new evidence presented. The motion carried unanimously.

PRESENTATION FROM CINDY BOLING

Cindy Boling, Director of Communications and Regulatory Board Liaison, from Professional Boundaries, Inc. gave a presentation on professional boundaries and courses offered by PBI.

ATTORNEY GENERAL'S REPORT

David Stubins updated the Board on the status of matter that have been referred to the Attorney General for legal action.
