



ORDER OF SUMMARY SUSPENSION

1.

WHEREAS, Judith Kalita Denton, M.D. ("Respondent") is licensed by the Georgia Composite Medical Board ("Board") to practice medicine in the State of Georgia, and Respondent's license expires September 30, 2017; and

2.

WHEREAS, Respondent's specialty is child psychiatry, as indicated on her physician profile; and

3.

WHEREAS, on or about March 3, 2017, the Board received correspondence from the Commonwealth of Virginia pursuant to Code of Virginia § 54.1-2400.6 (2017); and

4.

WHEREAS, said correspondence indicated that the Virginia Department of Health Professions had received information from Virginia Commonwealth University Health System that Respondent had an inpatient psychiatric admission on or about February 2, 2017; and

5.

WHEREAS, the above-referenced information indicated that Respondent, herself, had requested admission to the inpatient psychiatric unit; and

6.

WHEREAS, the above-referenced information further indicated that Respondent had self-reported dis-associative identity disorder;

NOW THEREFORE, the Board finds that Respondent's conduct poses an imminent threat to the public health, safety and welfare and imperatively requires emergency action, and hereby orders that the license of Respondent be and is SUMMARILY SUSPENDED, pursuant to O.C.G.A. § 50-13-18(c)(1), pending proceedings for further Board action.

If Respondent wishes to have an *expedited* hearing, Respondent shall execute, file and serve the Request for Expedited Hearing attached to this Order no later than fourteen (14) days from the day of service or receipt of this Order. *The failure of Respondent to request an expedited hearing in the aforementioned time period shall not be construed as a waiver of the right to a hearing in this matter.*

If Respondent wishes to have a hearing specially set after a specific date or after a particular occurrence, Respondent shall execute, file and serve the Request for Specially Set Hearing attached to this Order. *The failure of Respondent to request a specially set hearing shall not be construed as a waiver of the right to a hearing in this matter.*


