**CHAIR'S REPORT**

Dr. Gangasani reminded Board members about recusal packets and took a headcount for the March 6, 2025, meeting, which will be held in-person at the Board office. **EXECUTIVE DIRECTOR'S REPORT**

Mr. Jones shared updates that were for information purposes only.

**CORRESPONDENCE AND DISCUSSION ITEMS**

1. Correspondence from Dr. Katsiaryna Chuprasava – Question regarding differentiating between marijuana and CBD on drug screens.  
Response: Drug screens cannot distinguish between legal CBD and marijuana. Physicians may make a clinical decision by communicating with the patient and evaluating what they took based on their response. The Low THC Oil card, which is regulated by Department of Public Health, is not for over-the-counter CBD as Low THC Oil is a different product.
2. Correspondence from CJ- Question regarding Conflict of Interest with Nurse Practitioner treated in their own medical clinic by a physician employed by the clinic.  
Response: In the Board's opinion, it would be a conflict of interest for a nurse practitioner to seek treatment at a medical practice the nurse owns. Regarding practice ownership, there is no law that would prohibit the nurse from ownership, however per O.C.G.A. § 43-34-25(n), "it shall be unlawful for a physician to be an employee of an advanced practice registered nurse, alone or in combination with others, if the physician is required to supervise the employing advanced practice registered nurse."
3. Board Discussion regarding new DEA Telemedicine Prescribing proposed rule and two final rules. After discussion, the Board agrees that Dr. Norman will draft a comment of support for the proposed rule to be reviewed by the Board.

**Zoe Panizzi:**

**Question 1:** Rule 360-32-.01(11)(b) - If the APRN and Physician are providing telehealth services from Clarksville, TN and the clinic is in Hinesville, GA, where is the protocol being utilized?

Response: A delegating physician must have an active GA state license and primarily practice at a location within the state or within 50 miles of where the patient is located when receiving services. This applies to both in-person and telehealth services provided by an APRN and is independent of the business model. There are 534 miles between the cities listed.

Question 2: Rule 360-32-.05(2) - Does the annual onsite observation occur at the site the APRN is located (TN) or the site of the clinic in GA?

Response: The observation can take place at either location.

Question 3: Rule 360-3-.07(a)(2) - Can health history of the patient be completed by a therapist (LCSW, LCAS, LMFT, etc.)?

Response: The rule states that the patient's history shall be available to the GA physician, PA, or APRN providing the treatment or consultation via electronic means.

Question 4: Rule 360-3-.07(a)(8) – For the annual exam, would a referral to our case manager to assist a patient in establishing a PCP relationship suffice as due diligence?

Response: The requestor should speak with their organization's legal counsel regarding due diligence.

Amanda Kinder:

Question 1: Is a Form C required for ultrasound guided pelvic floor injections?

Response: Yes, a Form C is required for an APRN to perform guided pelvic floor injections.

Question 2: Is virtual supervision for purposes of the Form C ok?

Response: Supervision for the purpose of the Form C must be onsite supervision; virtual supervision is not acceptable.
