**RULES HEARING**

Dr. Weil convened the Public Hearing concerning the following proposed Rules amendments:

**Rule Chapter 360-15-.01, “Requirements for Physicians.”**

Dr. Weil asked if anyone was present to address the Board on the posted Rules amendments. One visitor was present and voiced his concerns regarding how many providers provide specialty education.

Dr. Retterbush made a motion to table Rule Chapter 360-15-.01, “Requirements for Physicians” and refer it to the Rules Committee for revisions. Mr. Wallace seconded the motion and it carried unanimously.


The Board voted to go into Executive Session to deliberate.
