VOLUNTARY SURRENDER

I, JOHN JARRETT MOSS, M.D., holder of License No. 48676 to practice medicine in the State of Georgia pursuant to O.C.G.A. Ch. 34, T. 43, as amended, hereby freely, knowingly and voluntarily surrender said license to the Georgia Composite Medical Board (hereinafter "Board"). I hereby acknowledge that this surrender shall have the same effect as revocation of my license, and I knowingly forfeit and relinquish all right, title, and privilege of practicing medicine in the State of Georgia, unless and until such time as my license may be reinstated, in the sole discretion of the Board.

I understand that I have a right to a hearing in this matter and I hereby freely, knowingly and voluntarily waive such right to a hearing. I also understand that should any request for reinstatement be entertained by the Board, the Board shall have access to the entire investigative file in this matter.

I further understand that upon applying for reinstatement, it shall be incumbent upon me to demonstrate to the satisfaction of the Board that I am able to practice medicine with reasonable skill and safety to patients and that if the Board is not so satisfied, the Board shall not reinstate my license.

This surrender shall become effective immediately upon acceptance thereof by the Board and docketing by the Board. I understand that this document will be considered to be a public record entered as the final disposition of the disciplinary matter pending against me and that this action shall be considered to be and may be disseminated as a final order of the Board.
