1. Record Retention Schedule for APRN files: – How long should the Board keep APRN fil
2. Questions from Representative Cooper: It would be helpful to know what the Board accepts as “specialty training” if they have not become certified as PMHNP’s? Acceptable criteria – Semester Course in Pharmacology, Mental Health etc. Does that mean they must complete a training program but don’t have to pursue certification? No, the APRN must complete a training program and receive certification. Does that mean they can take a three-hour course on psychotropic prescribing? No, a semester course must be completed. Does clinical experience count? If so, how much? Is it specified that it is under the supervision of a psychiatrist? Yes, must have two years of experience and the Delegating Physician statement, if they have already worked in a mental health capacity. Must also follow Board Rules.
3. Question from Tracy Marcotte: - Is it necessary for all Designated Physician to sign the Form A. Board responded Yes
4. Question from Ryan Noblett - Table refer to AG office for further review.
5. Review of Rule 360-32-.05– “Additional Requirements Regarding Physician Delegation to an APRN”. Approved - send to AG office for review.
