Dr. DeLoach attended the Attorney General Opioid Task Force meeting and provided the Board an update.

### INTERIM EXECUTIVE DIRECTORS REPORT

#### New Employees

Ms. Hughes introduced three new licensing tech employee, Eboni Harbin, Morico Knight, and Dwana Robinson.

1. Gregg Raduka, Ph.D., LPC, ICPS, Executive Director of “Let’s Be Clear Georgia” sent a letter pertaining to medical Cannabis physician report. The Board will review the report and notify Mr. Raduka of the outcome of the review.
2. Walter Moore, Jr., MACP Governor, Georgia Chapter American College of Physicians sent a letter asking for clarification of Rule 360-15-01 “Requirements for Physicians” regarding the Opioid CME requirement. Board advised the CME must be with-in the two years preceding the physician’s renewal to be counted as CME for renewal.
